In November, the Ministry of Education passed Bill 36, the School Amendment Act, which eliminated the Standard School Calendar (overview attached). As a result, School Districts are now required to establish their own school calendars beginning with the 2013-2014 school year. The School Calendar Committee, comprised of the partner groups in School District No. 23 (COTA, CUPE, COPVPA, COSBO and COPAC), has met and have drafted a proposed school calendar (attached) which meets the requirements of Bill 36.

We are now inviting parents to review the proposed calendar for the 2013-2014 school year and provide input. We are providing parents with the opportunity to provide their input to the proposal before it is discussed by our Board of Education at a public meeting prior to February 28, 2013.

OVERVIEW OF

BILL 36 - SCHOOL AMENDMENT ACT (SCHOOL CALENDAR REGULATION)

Bill 36 - School Amendment Act (School Calendar Regulation) was passed on November 8, 2012. Bill 36 outlines regulations which eliminate the standard school calendar.

School Districts are required to establish their own school calendars beginning with the 2013-2014 school year to commence on July 1, 2013.

The regulation is intended to provide more flexibility for the Boards of Education to offer more creative scheduling options to better meet the needs of the students.

The regulation prescribes:

Minimum hours of instruction for:

- Kindergarten 853 hours
- Grades 1-7 878 hours
- Grades 8-12 952 hours

School Calendars must:

- Provide the number and dates of the days in session
- The number and dates of each day of instruction
- The vacation periods and the statutory holidays
- The dates of each non-instructional day
- The number of hours of instruction offered students in each grade group

Consultation must:

- Provide opportunities for parents of students enrolled to provide input
- Provide representatives of employees of the Board to provide input

School Calendars must be made public one month (on or before February 28, 2013) in advance of the date they are to be submitted to the Minister of Education. The Boards of Education are required to submit their 2013-2014 school calendar to the Minister of Education by March 31, 2013.

The minimum hours of instruction for:

Kindergarten	853 hours	(based on 4.8 hours per day $x 184 = 883$)
Grades 1-7	878 hours	(based on 4.8 hours per day $x 184 = 883$)
Grades 8-12	952 hours	(based on 5.21 hours per day x $184 = 958$)

Provides the:

- Number and dates of the days in session
- The number and dates of each day of instruction
- Vacation Periods and the Statutory Holidays
- The dates of each Non-Instructional Day
- The number of hours of instruction offered students in each grade group
